The Devens' Utilities Department provides electricity, natural gas, water and sewer services to the Devens community. The infrastructure includes approximately 68 miles of power transmission line, 30 miles of gas line, 50 miles of water and sewer line, 5 electrical substations, 3 wells, 6 sewer lift pumps and a wastewater treatment facility. The utility systems are modified and expanded as required to meet both regulatory standards and the utility needs of our growing community at Devens, MA.

It is MassDevelopment's objective to provide competitive utility rates to Devens' customers. Although the Massachusetts Restructuring Act of 1997 does not apply to municipal utilities or to Devens, gas and electric rates are "unbundled" to allow our customers to compare our rates with those in other areas. To ensure our customers the best possible price for a reliable utility, our energy suppliers and operating and maintenance contractors are chosen on the basis of competitive bids. The energy components of the gas and electric rates represent the total purchased cost of gas supply and power supply that are adjusted from time to time as needed.

**Rates are effective for utility charges on or after April 1, 2022**

**Electric**

MassDevelopment purchases the electric power supply for Devens from the ISO – NE and through contracts with wholesale electric power supply vendors. Wellesley Municipal Light Plant is the operating and maintenance service provider.

## Wastewater

Wastewater is treated at a state-of-the-art 4.65 million gallons per day wastewater treatment facility located at Devens. United Water provides the operating and maintenance services for the system. Rate tiers are as follows.
